I have read and understand the contents of the application, and I hereby affirm that all the statements contained herein and in all exhibits attached hereto are true and binding, and that by accepting this Permit I agree to abide by all rules, regulations, and applicable laws including the Waiver of the Town's and Commission' liability as outlined in this application and any violation(s) may be deemed just cause for revocation of this permit. I also understand that the Recreational Shellfish Permit must be displayed at all times while out on the recreational shellfish beds.

**PLEASE NOTE:**

*The Town of Westport has limited parking available. The Canal Road parking area can only accommodate 6 to 8 cars. Should this parking area be full, there is no roadside parking allowed. This area is PRIVATE PROPERTY. There is no boat, kayak or canoe launching from the Canal Road parking area. The best access to the recreational shellfish beds is by boat. There is a state boat launch located on the Saugatuck River located at Underhill Parkway off Compo Road South.*

**Remember to CALL BEFORE YOU DIG – 203-838-9807 for closure notices.**

*The restocking of the recreational beds will likely take place in the spring and fall as needed, which may require at least a two week closure to allow the clams to depurate (cleanse) and dig in.*

If you are an out of state resident with a valid rental agreement within the State of Connecticut, the Westport Shellfish Commission will issue the Recreational Shellfish Permit as a CT Resident.
