APPLICATIONS FOR TOWN AND STATE TAX RELIEF ARE REQUIRED EVERY **TWO** YEARS

TAX RELIEF IS AVAILABLE TO HOMEOWNERS WHO RESIDE IN THEIR HOME AND ARE 65 AND OLDER OR PERMANENTLY AND TOTALLY DISABLED. TO ASSIST YOU IN DETERMINING ELIGIBILITY, THE INFORMATION IS GIVEN IN THE CHART BELOW.
