Agenda to include but not be limited to the following items and is subject to revision(s):

1. To take such action as the meeting may determine to approve the minutes of the Board of Selectwomen's and the Water Pollution Control Authority's public meetings of August 27, 2025.
2. To take such action as the meeting may determine, upon the recommendation of the Tax Collector and in accordance with C.G.S. Sec. 12-129, to approve the refunds of overpayments of taxes, as presented.
3. To take such action as the meeting may determine, upon the request of the Director of Human Services, to approve the Memorandum of Understanding between the Town of Westport, the Connecticut Energy Assistance Program (CEAP) Year 2024-2025 and Alliance for Community Empowerment, Inc., allowing Westport Human Services to serve as an intake site to assist Westport residents in completing the DSS/CEAP applications for energy assistance.
