Please find the attached materials relating to Text Amendment #866 to modify sections of the Zoning Regulations relating to Building Height to remove number of stories in the Residential and Multifamily Developments submitted by the Planning and Zoning Commission. This text amendment proposes to remove references to the maximum permitted number of stories in various residential zoning districts and to regulate building scale solely by maximum building height in feet, as measured pursuant to the Building Height definition in §5 of the Zoning Regulations.
